For ticks, dilute FOLIAFUME® XK Insecticide at the rate of 2 fluid ounces (4 Tbsp.) (60 ml) per 1 gallon (3.79 L) of water. (For puppies, use 1 fluid ounce (2 Tbsp.) (30 ml) per 1 gallon (3.79 L) of water). Apply directly to animal as a spray, sponge-on or a wash. Dip until animal's skin is wet. Do not rinse.
