Dear Mr. Krygsman:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable, subject to the comments listed below.

1. This product is in Toxicity Category III for eye irritation. Therefore, add "Causes substantial but temporary eye injury" as the second sentence under the Precautionary Statements section.
2. Under the First Aid section, revise the second statement to read "Have the person sip a glass of water if able to swallow." Add the following sentence as the third statement: "Do not induce vomiting unless told to do so by a poison control center or a doctor." Correct the spelling of unconscious in the last bullet ("uncious" to "unconscious").
3. Delete "Not for Resale Under This Label." This statement is in conflict with the formulators exemption.

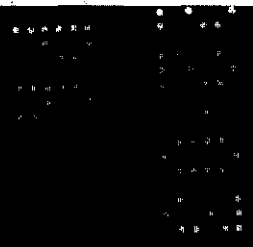
