GENERAL INFORMATION

Saga RTU FA is a ready-to-use insecticide containing 0.05% by weight active ingredient. *Add Attachment ①*

Not for use in sod farms or on grass grown for seed. Not for use in vegetable gardens.

One quart and one gallon pump spray containers - turn nozzle to spray position and squeeze trigger pump to spray.

One and five gallon containers without trigger sprayer - pour contents into conventional hand pressurized spray equipment and/or refill the above pump spray containers.

Fire Ants: *Add Attachment ②*
Apply as a gentle rain, thoroughly wetting top of mound and surrounding area to a diameter of 3 feet. Do not disturb mound before treating. Use approximately 1 pint per 10 - 12 inch mound. For best results, apply in cool weather or in early morning or late afternoon. Treat new mounds as they appear. Saga RTU FA gives quick reduction of stinging ants with total mound kill in approximately 5 days. One gallon treats 8 - 10 mounds. Store unused portion in original container.

ATTACHMENT 1

Use Saga RTU-FA to control outdoor pests by application as either a perimeter treatment or a residual spray. Do not allow adults, children or pets to walk on treated areas until spray has dried.

ATTACHMENT 2

Saga RTU-FA provides effective knockdown and residual control of fire ants.

ATTACHMENT 3

Perimeter Treatment: To help prevent infestation of buildings, apply Saga RTU-FA where pests are active and may find entrance. For example, treat a band of soil 6 to 10 feet wide around and adjacent to buildings and treat the building foundation to a height of 2 to 3 feet. Apply as a coarse spray. Thoroughly and uniformly wet the barrier area.

Residual Spray: To control ants, cockroaches, crickets, and spiders (contact kill), apply Saga RTU-FA as a coarse low pressure spray to surfaces of buildings, porches, screens, window frames, eaves, patios, lawns, refuse dumps and garages.

To Control Fleas and Ticks: Apply Saga RTU-FA as a coarse wet spray to areas where fleas and ticks are most likely to be found, such as, but not limited to, dog houses, kennels, runways, cracks and crevices in sidewalks, paths or patios, under plants, shrubs, trees, or other shaded, moist areas where pests may rest.

Wasps, Hornets, Yellow Jackets and Bees: Application should be made late in the evening when insects are at rest. Aim spray at nest opening in ground, bushes, in cracks and crevices and under attic rafters which may harbor nests (adequate care and proper protection should be used when spraying areas which require upward spraying). Saturate nests and contact as many insects as possible.

Flies, Midges, Gnats and Mosquitoes: For use as an aid in reducing annoyance from these insects. Spray outside surface of doors, screens, window frames, or wherever these insects may enter the room. Also, spray surfaces around light fixtures, on porches, in garages and other places where these insects alight or congregate.

Ornamental Pests: To control armyworms, bagworms, cankerworms, cutworms, elm leaf beetles, flea beetles, grasshoppers, gypsy moth larvae, adult Japanese and June beetles, lacebugs, leafhoppers, leafrollers, leaf skeletonizers, loopers, oakworms, plant bugs, pine moths, sawfly larvae, spanworms, stinkbugs, tent caterpillars, ticks, treehoppers, and webworms.
