  - d. Revise the environmental hazard statement fish statement so that it is identical to that approved for Scout Manufacturing Use Product, EPA Reg. No. 34147-1.

- Add the following statement describing "Pyrethroid f. Syndrome to the "Hazards to Humans and Domestic Animals" seection of the label.

"Skin exposure may result in a sensation described as a tingling, itching, burning or prickly feeling. Onset may occur immediately to 4 hours after exposure and may last 2-30 hours, without damage. Wash exposed areas once with soap and water. Relief from the skin sensation may be obtained by applying an oil-based cream."

2. Submit three copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
