- c. On the front panel above the ingredient statement, insert the following statement: "Not for use on plants grown for sale or other commercial use" or qualify the user category by stating, "For Household and Domestic Use Only."
- d. In the Environmental Hazards section, add the following: "This product is highly toxic to bees exposed to direct treatment or residues on blooming crops or weeds. Do not apply this product or allow it to drift to blooming crops or weeds if bees are visiting the treatment area."
- e. Because this product has been placed in acute category IV for each route of exposure, a first aid section is not required for this product, though you have the option of including the statements required for category III. Also, EPA will issue a PR Notice revising first aid statements in the near future. The following are the revised statements that will be required for products placed in category III and above. You may wish to incorporate these statements on your labeling:

"IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice. IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes. Call a poison control center for treatment advice. IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice."

Also, add the following statement near the first aid statements: "Have the product container or label with you when calling a poison control center or doctor or going for treatment."

EPA recommends that these statements be boxed and bulleted to present the information in a clear, easy-to-read fashion.

- f. Under directions for use INDOORS, in the first paragraph add the following before the retreatment statement: "Cover all food handling surfaces and cover or remove all food and cooking utensils or wash thoroughly after treatment. Exposed food should be covered or removed."
- g. Delete "but are not limited to" from the statement, "Permitted areas of use include but are not limited to . . . ."

- h. The retreatment statements throughout the labeling should include a maximum frequency of application, such as: “. . . but not more than \_\_\_ times per \_\_\_.”
- i. Under “Ants” on page 2 of the labeling, delete the word “freely” so the phrase reads as follows: “Spray ant trails and around doors and windows . . . “. Instructions to spray “freely” may conflict with the general instructions provided above to use only as a spot treatment and to “spray surface until slightly wet”.
- j. Under “[**SILVERFISH, CRICKETS, SPIDERS, EARWIGS:**]” provide more specific instructions similar to those provided above for spiders, centipedes, etc.
- k. Under “Ticks and Fleas on Surfaces”, revise the sixth sentence to read as follows: “For best results, pets should be treated with an appropriate flea [and/or tick] control product registered for use on pets . . . ”.
- l. Under **FLYING INSECTS** outdoors, insert “surfaces around” immediately before “light fixtures”.
- m. Under directions for treating ants outdoors, delete “freely” from the text, and revise the second to last sentence to read, “. . . and spray on and around debris until surface is wet.”
- n. At the end of the directions for treating pantry pests, insert the following: “Wash any exposed food handling surfaces and utensils before use.”
- o. After the first paragraph under “**OUTDOORS**” insert the following: “Do not contaminate fish ponds or apply directly to water.”
- p. Under directions for treating wasps, etc., add the following: “Aim spray at nest openings. Applications should be made late in the evening when insects are at rest.”
- q. Delete the first five sentences of the directions for treating fire ants unless the product will be packaged and sold with the “soil injector” referred to in these directions. Homeowner-use products may not require the use of specialized equipment such as soil injectors unless provided with the product.
- r. In the second paragraph under **FOR CONTROL OF ORNAMENTAL GARDEN INSECTS** revise the first sentence to read, “. . . multi-purpose spray in small ornamental gardens . . . ”.
- s. Revise the second to the last sentence under **FOR CONTROL OF**

ORNAMENTAL GARDEN INSECTS to read: "Spray insects directly whenever possible."

- t. Revise the bullet, "Contains No CFCs" to read, "Contains no CFCs or other ozone depleting substances. Federal regulations prohibit CFC propellants in aerosols."
3. We note that, according to our database, there are no present registrations of deltamethrin for the following pest claims that appear on this label: booklice, dermestids, palmetto bugs, chocolate moths, cluster flies, mud daubers. We assume you have on file efficacy data to support the use of this product for these pests.
4. Your corrosion characteristics and storage stability data have been reviewed and are acceptable.
5. Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

DS 210 works in two ways: 1) it kills bugs fast on contact; and 2) its residual action keeps on killing for up to 4 weeks after you spray. Contact kill gives you immediate results when spraying insects directly, while residual activity kills insects when they return to treated areas.

**SHAKE WELL BEFORE EACH USE.** Hold container upright. Do not spray up into air. Apply to surfaces only. Remove protective cap and direct spray away from face. Hold can 12-15 inches from surface being sprayed. Press button down and spray as directed. Spray surface until slightly wet.

DS 210 will not stain surfaces or fabrics where water alone causes no damage.

DS 210 insecticide is intended for use in and around residential structures and their immediate

Permitted areas of use include, but are not limited to: *apartments, atriums, attics, automobiles, basements, bathrooms, boats, cabins, campers, carports, cat sleeping quarters, clothes storage, condominiums, decks, dens, driveways, garages, gazebos, homes, kitchens, lanais, living rooms, parlors, patios, pet sleeping areas, play rooms, porches, recreational vehicles, rooms, solariums, storage areas, sun rooms, utility rooms and verandahs.*

#### INDOORS:

**Cockroaches** (including adult and immature stages of both non-resistant and organophosphate and carbamate resistant strains), **ants, booklice, boxelder bugs, centipedes, crickets, dermestids, firebrats, fleas, palmetto bugs, silverfish, sowbugs, ticks and waterbugs:** Apply thoroughly to all areas where these pests crawl and hide, especially in cracks and crevices, and hidden areas around sinks and storage areas, behind baseboards, around doors and windows, behind and under refrigerators, cabinets, sinks and stoves, the underside of shelves, drawers, bookcases, and similar areas. When pests are driven out, spray directly. Repeat as necessary.

**[ROACHES: Spray in cracks and crevices, around baseboards and other hiding places until wet. When driven out, spray bugs directly.]**

**Ants:** Spray freely around ant trails, doors and windows and other places where ants enter the house. Repeat as necessary.

**Carpenter Ants:** For effective control, locate and treat nests and surrounding areas. Apply around doors and windows and other places where ants enter premises and where they crawl and hide. Spray into infested wood through existing openings.

**Ticks and Fleas on Surfaces:** Remove pet bedding and destroy or clean thoroughly. Spray pet resting quarters. Adult fleas and larvae contacted by spray will be killed. Put fresh bedding down once spray has dried. Do not spray animals directly. For best results, pets should be treated with an appropriate product before allowing them to return to the treated area. Spray rugs and carpets where infestations are bad. Delicate fabrics should be tested for staining in an inconspicuous area prior to use.

**Spiders:** Apply along and behind baseboards, to window and door frames, corners, pipes, storage localities, attics, crawl spaces and other areas over which these pests may crawl.

**Centipedes, Ground Beetles, Pillbugs, Sowbugs, Scorpions and Ticks:** Apply around doors and windows and other places where these pests may enter premises. Treat baseboards, storage areas and other locations where these pests are found.

**[SILVERFISH, CRICKETS, SPIDERS, EARWIGS: Apply to areas infested by these pests or spray pests directly. Spray surfaces until wet.]**

**PANTRY PESTS - Grain Beetles (Rusty, Merchant and Saw-toothed), Flour Beetles (Red and Confused), Chocolate Moths, Cigarette Beetles, Clover Mites, Cluster Flies, Drugstore Beetles, Elmleaf Beetles, Rice Weevils, Lesser Grain Borers, Spider Beetles and Tobacco Moths:** Treat exposed stages. Remove all food-stuffs, utensils and shelf paper from area to be treated. Discard used shelf paper and any infested foodstuffs. Apply spray to shelves and in cracks and crevices behind and under cupboards and cabinets. Allow spray to dry prior to replacement of shelf paper, food and utensils.

**Carpet Beetles (Black, Furniture and Varied):** Spray on and under edges of floor coverings, under rugs and furniture and in closets or other localities where these insect are found.

**Webbing Clothes Moths:** Use this product as a crack and crevice treatment in closets and other storage areas where these pests are found. This is an adjunct treatment and will not control moth larvae already on clothes. Do not apply to clothing.

#### OUTDOORS:

Point nozzle away from face. Hold can on a slight downward angle, approximately 12 - 15 inches from surface to be sprayed. For best results, spray when air is calm. Spray with wind if breeze is blowing.

**PESTS ON OUTSIDE SURFACES OF BUILDINGS:** For control of building infestation to **ants, clover mites, crickets and sowbugs (pillbugs).** Spray foundation of building where insects are active and may find entrance up to a height of 2 to 3 feet. Apply as a residual spray to outside surfaces of buildings where insects tend to congregate. Spray areas include (but are not limited to) screens, window frames, eaves, porches, patios, garages and refuse dumps. Repeat treatment as necessary.

**CRAWLING INSECTS: ants, cockroaches (including Asian cockroaches), centipedes, crickets, mole crickets, water bugs and silverfish.** Spray infested surface of patio or picnic area, hitting as many insects as possible. Also spray legs of tables and chairs to repel ants. Spray ant hills for best control.

**Ants:** Spray freely around ant trails and hills. Spray around nests hidden under steps, brickwork, concrete, etc. Break apart accessible nests and spray freely on and around debris. Repeat as necessary.

**[ANTS: Spray ant trails and hills. If nest can be located, spray surface of nest until wet.]**

**Fire Ants:** To treat mounds, use soil injector. To maximize distribution, insert injector into the mound full length, if possible. Inject the mound at 3 - 6 sites at a rate of 5 - 10 seconds of spray per site. For very large mounds (over 36 inches in diameter), increase the number of injection sites. Space injection sites in a circular pattern on the mound surface with one site in the center. To quiet active ants on the surface, sweep surface with spray from a distance of 18 inches. For best results, apply in cool weather or in early morning or late evening hours. Treat new mounds as they appear.

**Lone Star Ticks, Dog Ticks, Crickets, Fleas and Earwigs:** Apply thoroughly to infestation in bushes, grass or weeds.

**Wasps, Mud Daubers, Hornets and Bees:** Spray nests and bees directly.

**FLYING INSECTS: Houseflies, gnats, mosquitoes and small flying moths:** Use only on outdoor surfaces. Spray outside surfaces of window and door frames and other areas where these pests may enter the home. Also spray localized resting areas, such as under eaves, porches, light fixtures and cords, railings, etc. where these insects may rest. Insects coming to rest on treated surfaces will be killed.

**FOR THE CONTROL OF ORNAMENTAL GARDEN INSECTS:** For use on roses, dahlias, asters and other ornamentals to kill *Japanese beetles* hit by spray, as well as *whiteflies, aphids, army worms, lace bugs, mealy bugs, exposed thrips, pavement ants, spiders, spider and red mites, clover mites and leafminers.*

May be used on plants, as well as a multi-purpose spray in small gardens and for spot treatments of incipient insect infestations to prevent spreading in large garden areas.

May also be used on other plants such as African violets, asters, azaleas, begonias, camellias, carnations, chrysanthemums, delphiniums, dogwood, English ivy, euonymus, fuschia, geraniums, crassula, grape vine, Kentia palm, laurel, marigolds, rhododendrons, rubber plants, snapdragons, stocks, wandering Jews and zinnias.

When spraying plants, do not operate closer than 18 inches. Use sweeping motion. Spray in one second bursts. Be cautious about wetting tender foliage, young plants and new growth. Do not spray plants when temperatures exceed 90°F. Contact insects directly whenever possible. Repeat treatment as necessary.

#### STORAGE AND DISPOSAL

**Storage:** Do not store near heat or open flame. Store in a cool, dry area away from children.

**Container Disposal:** Replace cap, wrap container in several layers of newspaper and discard in trash. Do not incinerate or puncture. Can may be disposed of with other recyclables where local law permits.
