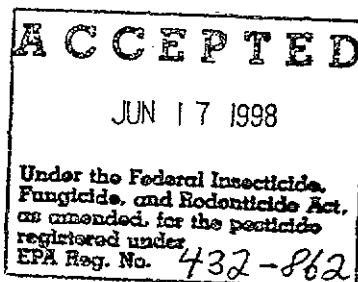

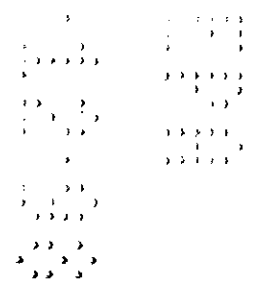

AEH Ready-To-Use is pre-mixed and ready to apply. AEH Ready-To-Use is to be used as a "spot" treatment to kill weeds and grass around trees, shrubs, fences, walks, patios, driveways, sidewalks, in flower beds, around houses, buildings, wooded lots, storage and recreational areas and to spot kill weeds in lawns. This product is a weed and grass killer **that will injure or kill most green vegetation contacted**. It will kill most annual and perennial weeds, grasses and other unwanted vegetation. AEH Ready-To-Use will not interfere with seed germination or root growth of desirable plants. Treated areas can be reseeded or replanted 4 days after application.

To avoid spray drift onto desirable plants, do not spray during windy conditions. If spraying in areas adjacent to desirable plants, use a shield made of cardboard, plywood, or sheet metal while spraying to help prevent spray from contacting foliage of desirable plants. If spray contacts desirable plant foliage, immediately rinse the foliage with water. Avoid spray contact of foliage and green bark of desirable plants. To avoid tracking product on to desirable vegetation, keep people and pets off treated areas until the spray is thoroughly dried.

HOW TO APPLY

Adjust nozzle to a coarse spray setting. Hold spray tip 1 to 2 feet away from the weed or grass and apply to thoroughly wet the weed or grass, but avoid spray run-off. Repeat treatments may be necessary to control plants generating from underground parts or seed. AEH Ready-To-Use works best in warm sunny weather with daytime temperatures above 60°F. Weed control may be reduced or delayed when applications are made to weeds under stress due to drought or cool temperatures.
