On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act. Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is unconditionally registered in accordance with FIFRA sec. 3(c)(5), provided that you:

1. Make the following labeling changes listed below before you release the product for shipment:

a. EPA will issue a PR Notice revising FIRST AID statements in the near future. The following are revised statements that will be required for products placed in toxicity category III and above. You may wish to incorporate these statements on your labeling at this time.

 - c. The second paragraph of the warranty statement appears to undercut the use directions and precautionary statements.  - d. The results of the corrosion characteristics study (830.6320), which is in progress, must be submitted on completion to the Agency for evaluation.

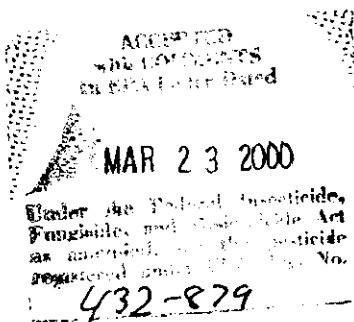
