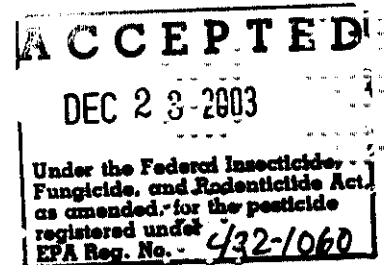

DIRECTIONS FOR USE ON HORSES AND PONIES:

Not for use on horses intended for food. Remove pets, birds, and cover fish aquarium before spraying.

Brush the animal thoroughly to remove loose dirt and dust.

Prepare the appropriate dilution of Pyrenone Stabilene E.C. in the amount required for immediate use (about one quart per horse). Diluted Pyrenone Stabilene E.C. should be used within 24 hours.

To Kill and Repel House Flies, Horn Flies, Gnats and Mosquitoes: Dilute 1 part concentrate and 14 parts water.

To Kill and Repel Horse Flies, Stable Flies, Deer Flies and Face Flies: Dilute 1 part concentrate with 9 parts water.

Moisten (do not soak) a folded 12" square piece of turkish toweling with the dilution. Rub against then with hair growth. Give special attention to facial areas, neck, legs, shoulders and shanks, where the flies are most often seen. Avoid contact with eyes or nostrils. Apply thoroughly to

moisten hair. If desired, the sheen of the coat may be enhanced by light brushing following application. For best results, apply Pyrenone Stabilene E.C. daily.

To Kill Fleas and Lice:

Using a dilution of 1 part concentrate to 49 parts water, apply enough spray to thoroughly wet the skin of the animal. Repeat treatment as necessary. To help in prevention of reinfestation, thoroughly spray premises and sleeping quarters, paying particular attention to cracks and crevices.

To Kill Attached Ticks:

Saturate a cloth with this concentrate and daub directly on ticks. Avoid contact with eyes or nostrils.

IN HORSE BARN, STABLE AND TACK ROOMS:

To control Flies, Mosquitoes, and Gnats, dilute at a rate of 1 part concentrate to 24 parts water or oil and apply as a fog or fine mist directing spray toward the ceiling and upper corners until the area is filled with mist using about 2 ounces per 1000 cubic feet of space. For best results, close doors and windows before spraying and keep them closed for ten to fifteen minutes. Vacate the area and ventilate before reoccupying. Repeat application as necessary.

USE AS A WATER SPRAY:

1-9 Dilution: Mix 1 quart of emulsifiable concentrate Pyrenone Stabilene E.C. with 9 parts water to make 2 1/2 gallons of spray. Stir before using. Apply at the rate of 1 pint to 1 quart of diluted spray per animal, depending on the size of the animal.

Horn Flies, Mosquitoes, and Gnats: Apply as necessary to give continued protection.

Stable Flies and House Flies: Apply as necessary to give continued protection.

Horse Flies and Deer Flies: Apply as necessary to give continued protection.

This dilution will kill Horse Flies, Stable Flies, House Flies, Horn Flies, Mosquitoes, and Gnats on the animal at the time of application.

1-14 Dilution: Mix 1 quart of emulsifiable concentrate Pyrenone Stabilene E.C. with 14 quarts of water to make 3 1/2 gallons of spray. Stir before using. Apply at the rate of 1 pint to 1 quart per animal depending on the size of the animal.

Horn Flies, Mosquitoes, and Gnats: Apply as necessary to give continued protection. This dilution will kill Horn Flies, Mosquitoes, and Gnats on the animal at the time of application.

STORAGE & DISPOSAL

Do not contaminate water, food and feed by storage or disposal. Open dumping is prohibited.
