Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Offer for recycling, if available or dispose of empty bag in a sanitary landfill or if allowed by government regulations by burning or incineration. If bag is burned, stay out of smoke. Consult Federal. State or Local disposal authorities for approved alternative procedures.
