

Contains an N-methyl ca	arbamate that Inhibits cholinesterase.
If swallowed	 Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.
If inhaled	 Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.
If on skin or clothing	 Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice.
If in eyes	 Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

Note To Physician: ANTIDOTE - Administer atropine sulfate in large therapeutic doses. Repeat as necessary to the point of tolerance

Compound inhibits cholinesterase resulting in stimulation of the central nervous system, the parasympathetic nervous system, and the somatic motor nerves. Do not give morphine. Watch for pulmonary edema, which may develop in serious cases of poisoning, even after 12 hours. At first sign of pulmonary edema, the patient should be placed in an oxygen tent and treated symptomatically.

HAZARDS TO HUMANS

WARNING: May be fatal if swallowed. Harmful if inhaled or absorbed through the skin. Avoid contact with eyes, skin, or clothing. Wear chemical resistant gloves, protective clothing, and goggles. In case of contact, wash immediately with soap and warm water. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Outdoor uses restricted to (a) residential and commercial applications to surfaces of buildings, and (b) around patios griveways, sidewalks, and foundations.

- (2) Uses for which USEPA has accepted the required data and/or citations of data that the formulator has submitted in support of registration.
- (3) Uses for experimental purposes that are in compliance with USEPA requirements. STORAGE AND DISPOSAL
