Dear Dr. Pangilinan:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act as amended is acceptable provided the following corrections are done:

- 1. Rewrite the Precautionary Statement to read as follows: Caution: Harmful if swallowed or absorbed through skin. Avoid Contact with ski, eyes, or clothing. Wash thoroughly with soap and water after handling. Keep children and pets off treated area until dry.
- 2. The Agency's chemical resistant glove statement must replace "waterproof glove" where ever it is used on this label. The Agency's glove statement is as follows: Chemical-resistant gloves made of any waterproof material such as barrier laminate, butyl rubber, nitrile rubber, neoprene rubber, natural rubber, polyethylene, polyvinylchloride (PVC) or viton.
- 3. Also add to the PPE (Applicators and other handlers must wear "Protective eye wear".
- 4. On page 2 of the label remove the word "General" from the title General Information or rename the section to a more acceptable term. As it now is named the Agency finds it to be too vague.
- 5. Change the word "should" to the word "must" on pages 4 and 5.

#### **GENERAL INFORMATION**

MERIT 1 G Greenhouse and Nursery Insecticide is for systemic insect control on ornamentals, fruit and nut trees, and vegetable plants in greenhouses, nurseries and interior plantscapes. MERIT 1 G Greenhouse and Nursery Insecticide is a systemic product and will be translocated upward within the plant. To assure optimum effectiveness, the product must be placed by

incorporation where the roots of the plant can absorb the active ingredient. Irrigate moderately but thoroughly after application, allowing no leaching and runout from containers for at least three irrigations or 10 days whichever is longer.

**Resistance:** Some insects are known to develop resistance to insecticides after repeated use. As with any insecticide, the use of this product should conform to resistance management strategies established for the use area. Consult your Cooperative Extension Service for resistance management strategies and recommended pest management practices for your area.

For resistance management purposes, a foliar application of any chloronicotinyl insecticide following a MERIT 1 G Greenhouse and Nursery Insecticide soil application in the same crop is not recommended.

**Incorporation:** Incorporation of MERIT 1 G Greenhouse and Nursery Insecticide can be achieved by cultivation, irrigation, rainfall, mechanical placement or by using mechanical soil or media mixing equipment.

Woody Perennials: Onset of protection is slower than in herbaceous species. A delay of 2 or more weeks should be expected. Longer delays may be expected with larger plants. Application should therefore be made in advance of expected insect activity.

Bark Media: Media with 30% or more bark content when treated with MERIT 1 G Greenhouse and Nursery Insecticide may confer a shorter period of protection.

#### APPLICATION TO GRASSY AREAS IN NURSERIES

MERIT 1 G Greenhouse and Nursery Insecticide can be used for the control of soil inhabiting pests of grassy areas of nurseries, such as northern and southern masked chafers, *Cyclocephala borealis, C. immaculata*, and/or *C. lurida*; Asiatic garden beetle, *Maladera castanea*; European chafer, *Rhizotrogus majalis*; green June beetle, *Cotinis nitida*; May or June beetle, *Phyllophaga* spp.; Japanese beetle, *Popillia japonica*; Oriental beetle, *Anomala orientalis*; *Euetheola humilus rugiceps*; billbugs, *Sphenophorus* spp.; annual bluegrass weevil, *Listronotus maculicollis*; black turfgrass ataenius, *Ataenius spretulus*; *Aphodius* spp.; and mole crickets, *Scapteriscus* spp. MERIT 1 G Greenhouse and Nursery Insecticide can also be used for suppression of cutworms and chinchbugs. MERIT 1 G Greenhouse and Nursery Insecticide can be used as directed on nursery grass in sites such as under or around field or container grown plants, on roadways or other grassy areas in or around nurseries. MERIT 1 G Greenhouse and Nursery Insecticide cannot be used on commercial sod farms.

The active ingredient in MERIT 1 G Greenhouse and Nursery Insecticide has sufficient residual activity so that applications can be made preceding the egg laying activity of the target pests. High levels of control can be achieved when applications are made preceding or during the egg laying period. The need for an application can be based on historical monitoring of the site, previous records or experiences, current season adult trapping or other methods. Optimum control will be achieved when applications are made prior to egg hatch of the target pests, followed by sufficient irrigation or rainfall to move the active ingredient through the thatch.

Applications should not be made when grassy areas are waterlogged or the soil is saturated with water. Adequate distribution of the active ingredient cannot be achieved when these conditions exist. The treated grassy area must be in such a condition that the rainfall or irrigation will penetrate vertically in the soil profile. Application cannot exceed a total of 40 lbs. of product (0.4 lb. of active ingredient) per acre per year.

For systemic insect control on fruit and nut trees, and vegetable plants, greenhouse, interior plantscapes, and nursery ornamentals grown in flats, benches, beds and containers.

On plants with a production cycle of less than one year, application is not to exceed a frequency of more than once each 16 weeks for a particular plant. On stock plants and woody crops with a production cycle of greater than one year, application may not exceed once a year.

Food Crops: Treated areas may be replanted with any crop specified on an imidacloprid label, or with any crop for which a tolerance exists for the active ingredient.

For crops not listed on an imidacloprid label, or for crops for which no tolerances for the active ingredient have been established, a 12 month plant-back interval should be observed.
