

MERIT 0.5 Plus Turf Fertilizer can be used for the control of soil inhabiting pests of turfgrass, such as Northern & Southern masked chafers, *Cyclocephala borealis*, *C. immaculata*, and/or *C. lurida*; Asiatic garden beetle, *Maladera castanea*; European chafer, *Rhizotroqus majalis*; May or June beetles, *Phyllophaga* spp.; Japanese beetle, *Popillia japonica*; Oriental beetle, *Anomala orientalis*; Billbugs, *Sphenophorus* spp.; Annual bluegrass weevil, *Hyperodes* spp.; Black turfgrass ataenius, *Ataenius spretulus*; *Aphodius* spp.; European Crane Fly *Tipula paludosa*; and mole crickets, *Scapteriscus* spp. MERIT 0.5 Plus Turf Fertilizer can be used as directed on turfgrass in sites such as home lawns, business and office complexes, shopping complexes, multi-family residential complexes, golf courses, airports, cemeteries, parks, playgrounds, and athletic fields. APPLICATION TO ORNAMENTALS

MERIT 0.5 Plus Turf Fertilizer can be used as a broadcast application on ornamentals in commercial and residential landscapes, as well as on landscaped areas of golf courses and other recreational areas. This is a systemic product, with the active ingredient being absorbed by the roots and translocated upward within the plant. Optimum control will be achieved when applications are followed by sufficient mechanical incorporation, irrigation or rainfall to place the active ingredient into the soil. Application should be made prior to anticipated pest infestation to achieve optimum levels of control.

Applications of MERIT 0.5 Plus Turf Fertilizer cannot exceed a total of 80 lb (0.4 lb of active ingredient) per acre per year.
