Section II - Explanation

Bayer Advanced is submitting a label **Notification** for **Merit 2.5 PR**, EPA Reg. No. 432-1399-72155 (ABN: Bayer Advanced 2-in-1 Insect Control Plus Fertilizer Plant Spikes), in accordance with PR Notice 98-10. The purpose of this Notification is to add the Oregon State use restriction for imidacloprid on Linden, Basswood and other Tilia species issued on November 12, 2013 (clarification letter dated November 20, 2013). The following changes have been made to the label:

1. The use restriction statement for linden, basswood and other Tilia species is located in the Directions for Use section in the Before You Use row.

2. Due to this use restriction, the word "all" was removed from the claim which now reads "For Potted Plant, Indoors and Outdoors.

3. The word "all" was removed in the Quick Facts, Where to Use Section and now reads "In potted plants except edible plants, herbs, fruits, or vegetables."

Enclosed are **2** copies of the product label (the clean copies and one copy with all changes highlighted in yellow).

This notification is consistent with the provision of PR Notice 98-10 and EPA regulations at 40 CFR 152.46, and no other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to EPA. I further understand that if this notification is not consistent with the terms of PR Notice 98-10 and 40 CFR 152.46, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA.


