On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. - 2. You will make the following label changes before you release the product for shipment:
  - a) Revise the EPA Registration Number to read "EPA Reg. No. 432-1461."
  - b) Rearrange the First Aid section so that the "If on skin..." statements are listed first. This is the most acutely toxic route of exposure.
  - c) Revise the Precautionary Statements to read "Causes skin irritation. Causes moderate eye irritation. Do not get on skin, in eyes, or on clothing. Wear coveralls worn over short sleeved shirt and short pants, socks, chemical resistant footwear and chemical resistant gloves. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Remove and wash contaminated clothing before reuse".
  - d) Revise the Pesticide Disposal statements to read "Wastes resulting from the use of this product maybe disposed of on site or at an approved waste disposal facility."
  - e) Delete "Not for resale under this label" since it is in conflict with the formulator exemption under 40 CFR 152.85.

- f) Under Directions for Use qualify mosquito control by adding in parenthesis "(non-ULV)".
- g) Add the following use limitations under Directions for Use:

"Note: Not for use to formulate products to be used:

- In warehouses where raw or cured tobacco is stored.
- In warehouses while raw agricultural commodities for food or feed are stored.
- In greenhouses where crops for food or feed are grown.
- In USDA meat and egg processing plants.
- For mosquito control (ULV) products."

  - o "Bayer Environmental Science USA LP makes no other warranties..."
  - "Bayer Environmental Science disclaims any liability whatsoever..."

- 3. Please submit three (3) copies of your final printed labeling before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.

The basic confidential statement of formula (CSF) dated 06/19/2006 is acceptable. The four (4) alternate CSFs, dated 06/20, 06/21, 06/22, and 06/23/2006 are acceptable. Copies of the CSFs have been placed in the file for the subject product.
