The supplemental labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable.



SPECTICLE 20 WSP HERBICIDE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Read this label and the product package label before using this product. This Supplemental Label must be in possession of the user at the time of pesticide application. Follow all applicable directions, restrictions, Worker Protection Standard requirements, and precautions on the registered product label for Specticle 20 WSP Herbicide.

DIRECTIONS FOR USE OF SPECTICLE 20WSP ON TURF

USE PRECAUTIONS FOR SPECTICLE 20WSP ON TURF

- Do not apply to golf course tees or collars.
- Do not verticut within 1 month prior to or after an application of Specticle 20WSP.
- Do not apply to newly seeded turf. Established turf is defined as turf 1 year after seeding.
- Do not apply to turf that is showing signs of stress including winterkill, spring dead spot, transitioning ryegrass.
 Additional stress factors include, but are not limited to, bermudagrass spring root decline, soil compaction, diseases (both foliar and root), nematodes, salt accumulation, shade, foot or equipment traffic, and drought. Use of Specticle 20WSP may increase severity of symptoms on these turf conditions.
- Do not use on the following cultivars of Seashore Paspalum (Paspalum vaginatum): Seaspray, Salam, Sea Isle 2000, SeaDwarf, Aloha, SeaGreen, SeaWay, Adalayd/Excalibre, Neptune, and any other cultivar not listed on the label.

Activated charcoal has been shown to deactivate Specticle 20WSP if applied within several days of application. Application of charcoal within 2 weeks after an application of Specticle 20WSP will not reverse symptoms immediately, but it will aid in turf recovery over time. If it should be necessary to re-sod areas treated with Specticle 20WSP, apply activated charcoal to bareground prior to laying the sod. Follow directions for the amount of charcoal to apply on the activated charcoal label.

This supplemental label expires on June 23, 2014 and must not be used or distributed after this date.
