The supplemental label amendment referred to above, submitted in connection with registration under FIFRA section 3(c)(5), is acceptable provided that you:

- 1. Submit and/or cite all data required for registration/registration review of your product under FIFRA section 3(c)(5) when the Agency requires all registrants of similar products to submit such data.
- 2. Submit five (5) copies of your final printed labeling before you release the product for shipment. Final printed labeling means the label or labeling of the product when distributed or sold. Clearly legible reproductions or photo reductions will be accepted for unusual labels, such as those silkscreened directly onto glass or metal containers or large bags or drum labels. Refer to the A-79 enclosure for further description of final printed labeling.

The supplemental label expires on May 15, 2016. This approval does not eliminate the need for continual reassessment of the pesticide. If EPA determines at any time that additional data are required to maintain in effect an existing registration, the Agency will require submission of such data under section 3(c)(2)(B) of the Federal Insecticide, Fundicide and Rodenticide Act.

Your release for shipment of the product bearing the amended labeling constitutes acceptance of these terms. A stamped copy of the supplemental label is enclosed for your records.
