2. You are required to submit to the Agency a new avian reproduction toxicity study conducted on a waterfowl species (mallard). The deadline for you to submit this required data to the Agency is October 1, 2016. Your failure to provide this data in a timely or adequate manner may result in initiation of a cancellation action against your registration.
3. Submit one copy of the final printed label for the record before you release the product for shipment. Assure that the EPA establishment number and net contents are added to the final printed label. Also assure that a batch code is included for all non-refillable containers of this product.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency.
