



Wood should be dry, unpainted, well seasoned and bark free.

5 of 5  
drenching coats with a mop, sprinkling can or brush.

DIPPING: Soak five minutes or more for each inch of thickness of wood. Posts, poles and timbers should soak 24 to 48 hours.

Allow treated surface to dry (usually all solvent is gone in 24 hours) before painting or varnishing.

Can be painted over when thoroughly dry.

STORAGE AND DISPOSAL

DO NOT USE OR STORE INSIDE THE HOME. DO NOT REUSE EMPTY CONTAINER. KEEP AWAY FROM FOOD AND FEED. KEEP CLOSURES TIGHT AND UPRIGHT TO PREVENT LEAKAGE.
