This is in response to your request to amend the registration of the subject product to include label revisions for the limiting use to "Manufacturing Use Only" and deletion of "End Uses" and revised Confidential Statement of Formula (CSF) per our letter dated November 29, 1994.

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable provided that you make the following label revisions:

- Add the heading "Directions for Use" on front panel.
- Under the "Directions for Use" section, add the statement: "It is a violation of Federal Law to use this product in a manner inconsistent with its labeling".
- 3. In the "Directions for Use", the following statement must appear: "Formulators using this product are responsible for obtaining EPA registration of their formulated products".
- 4. Revise the "IF Swallowed" statement of the "Practical Treatment" to read as follows; "IF Swallowed, drink large amounts of water. Do Not induce vomiting. Call a physician or poison control center immediately".



#### AGRICULTURE

For postharvest preservation of fruits and vegetables, for which tolerances have been established, use 0.1-0.3% DOWICIDE 1 by wt in an aqueous solution or 0.5-2.0% DOWICIDE 1 by wt in an approved wax emulsion. Apply by spraying, dipping, or flooding:
