DIRECTIONS

Use as a fumigant for the control of insect pests infesting citrus, pineapples, guavas, papayas, mangoes, cucumbers, bell peppers, bitter melon, cavendish bananas, zucchini squash, string beans, litchi nuts, plums and cantaloupes.

Use only in accordance with the recommendations and instructions issued by the United States Department of Agriculture for various quarantine programs and for the Mediterranean Fruit Fly control program. Fumigations should be conducted only with the approval and supervision of proper U.S.D.A. authorities.

USE PRECAUTIONS

The conditions of use of this fumigant are prescribed by governmental regulations. The buyer assumes all risk of damage to the fumigated material. The buyer should consult with the United States Department of Agriculture concerning the type and extent of damage, if any, to be expected. To avoid or minimize damage, do not use more than 1 pound of Dow Ethylene Dibromide per 1000 cubic feet of fumigated space.

NOTE: Do not use containers or handling equipment of aluminum, magnesium, or their alloys, as under certain conditions ethylene dibromide may be severely corrosive to such metals. Exposure to ethylene dibromide or its vapors may cause serious damage to rubber products, surface finishes, and certain types of plastics products.
