USE DIRECTIONS

Use LORSBAN 4E insecticide for control of peach tree borers infesting peach trees by application as a trunk spray before newly hatched borers enter the trees. Consult your State Agricultural Experiment Station or Extension Service specialist for proper time to treat in your area. Mix 3 quarts of LORSBAN 4E insecticide with 100 gallons of water and apply as a coarse, low-pressure spray using suitable hand or power spray equipment to give uniform coverage of tree trunks. Thoroughly wet all bark areas from ground level to scaffold limbs. Do not allow spray to contact fruit. Make only one application per season. **Do not apply within 14 days before harvest. Do not graze treated orchards to meat or dairy animals.**

USE PRECAUTIONS

LORSBAN 4E is toxic to fish, wildlife, and birds. Fish and crustaceans may be killed if their waters are contaminated with this product. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from treated areas. Do not contaminate water by cleaning of equipment or disposal of wastes. **Use this product only as specified on this label.**
