# LORSBAN 5G GRANULAR INSECTICIDE

**CONTROLS BANANA ROOT BORERS IN BANANA PLANTINGS**

**ACTIVE INGREDIENT:**

Chlorpyrifos [O,O-diethyl O-(3,5,6-trichloro-2-pyridyl)phosphorothioate]..... 5%

**INERT INGREDIENTS..... 95%**

**USE DIRECTIONS**

Apply LORSBAN 5G granular insecticide in a uniform band 6 inches wide around the base of each banana plant and in the space between the mother plant and daughter or follower plant to form a protective barrier around each plant. The granules should be applied at the rate of 60 grams per plant, preferably using a shaker can to ensure uniform coverage. Retreat at 6 month intervals if trap counts indicate the buildup of potentially damaging borer population levels.

**USE PRECAUTIONS**

This product is toxic to fish, birds, and other wildlife. Keep out of any body of water. Apply this product only as specified on this label.

Dispose of wastes by burying in non-crop lands away from water supplies. Dispose of container by burying with wastes or by burning. If burned, keep out of smoke and fumes.

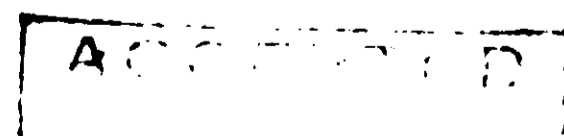
