The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable with the conditions listed below:

to revise the "first aid" per PR Notice 2001-1

## **Conditions**

Revise the label as follows:

1. Under the "First Aid" Statement add the following:

For Toxicity Category I eye and skin irritants, use the following "Note to Physician".

"Note to Physician: Probable mucosal damage may contraindicate the use of gastric lavage".

- 2. Under the Precautionary Statements revise "Hazard to Humans" to read: "Hazards to Humans and Domestic Animals".
- 3. Under the Environmental Hazards Statement revise the first sentence to read: "This pesticide is toxic to fish and aquatic organisms".
- 4. Delete the "s" on the word "Ingredients" in the Ingredient Statement.
- 5. Center the signal word "DANGER" underneath the phrase "Keep Out of Reach of Children".
