It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

#### FOR USE IN METALWORKING FLUIDS

BIOBAN P-1487T is recommended for use in soluble oils, semi-synthetic and synthetic fluids. It should be added directly in the sump (with agitation). A dose of 1000-2000 ppm is recommended for initial treatment; higher levels up to 2500 ppm, but no greater, for fouled systems. After addition of BIOBAN P-1487T the system should be circulated for about one hour before shut down.

In Diluted Fluids: An initial concentration of 1000to 2500 ppm of BIOBAN P-1487T is sufficient to control gross microbial growth. For example, add 1.0 lb of BIOBAN P-1487 T to 1000 lb of fluid to obtain a dose level of 1000 ppm in the fluid.

Maintenance Dosage: Add 500-1000 ppm of BIOBAN P-1487T to maintain control of the system

#### FOR USE IN HYDROCARBON PRESERVATION

To control the growth of problem microorganisms associated with the fuel.

In General Use: Add BIOBAN P-1487T to storage tanks or fuel tanks for control of microbial growth in diesel oil, fuel oil, gasoline, or kerosene. Treatment may be performed by slug dosage or by intermittent metering to attain the proper concentration of BIOBAN P-1487T.

For Storage Above Water: Add 2.2 gallons of BIOBAN P-1487T to each 1000 gallons of water in the bulk storage system to achieve a concentration of approximately 2200 ppm. To facilitate mixing dissolve each gallon of BIOBAN P-1487T in 100 gallons of water and add this solution directly to the water phase in the tank with minimal agitation.

For Storage in Tanks Without Intentional Water: Add 0.28-2.2 gallon of BIOBAN P-1487T directly to each 1000 gallons of hydrocarbon in the system to obtain a concentration of approximately 280-2200 ppm.

In a Fuel-Treatment Pre-Mix: BIOBAN P-1487T may be mixed with other fuel additives for addition to fuel. The end user must add sufficient BIOBAN P-1487T to the pre-mix to provide 280-2200 ppm of BIOBAN P-1487T in the treated fuel.
