### STORAGE AND HANDLING

UCARCIDETM 125 Antimicrobial solutions are incompatible with many commonly used materials of construction such as steet, galvanized iron, sturmium, tin, and zinc. These solutions can be stored and handled in baked phenolio-lined steet, polyethylene, stainless steet, or reinforced epoxy-plastic equipment. This product freezes at about -14°F (-10°C). Therefore, unless the storage tank is niside or underground, heating and insulation may be required. If heating is needed, exposure to high terriperatures should be avoided. For short storage times (up to about 1 month), temperatures of up to 100°F (37.8°C) can be tolerated but the preferred maximum storage temperature is about 80°F (26.7°C).

A stainless steel centrifugal pump is suggested for transfer service. Spiral-wound stainless steel with TEFLON® is suitable for gaskets and packing.

# DIRECTIONS FOR USE

### WATER FLOODS

UCARCIDE TM 125 Antimicrobial should be added to a water flood system at a point of uniform mixing

Initial Treatment: When the system is noticeably contaminated, add 200 to 10,000 ppm UCARCIDETM 125 Antimicrobial to the system (0.2 to 10.0 gallons UCARCIDETM 125 Antimicrobial per 1,000 gallons flood water). Repeat until control is achieved.

Subsequent Dose: When microbial control is evident, add 40 to 10,000 ppm UCARCIDE™ 125
Antimicrobial (0.04 to 10.0 gallons UCARCIDE™ 125 Antimicrobial per 1,000 gallons flood water)
to the system weekly, or as needed to maintain control.

### DRILLING, COMPLETION, AND WORKOVER FLUIDS

UCARCIDETM 125 Antimicrobial should be added to a drilling fluid system at a point of uniform mixing such as the circulating mud tank.

Initial Treatment: Add 100 to 2,000 ppm UCARCIDETM 125 Antimicrobial (0.4 to 8.0 gallons UCARCIDETM 125 Antimicrobial per 100 barrels of fluid) to a freshly prepared fluid depending on the severity of contamination.

Maintenance Dosage: Maintain a concentration of 100 to 2,000 ppm UCARCIDETM 125

Antimicrobial by adding 0.4 to 8.0 gallons of UCARCIDETM 125 Antimicrobial per 100 barrels of additional fluid, or as needed, depending on the severity of contamination.

### **PACKER FLUIDS**

UCARCIDETM 125 Antimicrobial should be added to a packer fluid at a point of uniform mixing such as a circulating holding tank. Add 100 to 1,200 ppm UCARCIDETM 125 Antimicrobial (0.4 to 5.0 gallons UCARCIDETM 125 Antimicrobial per 100 barrels of fluid) to a freshly prepared fluid depending on the severity of contamination. Seal the treated packer fluid in the wall between the casing and production tube.

## GAS PRODUCTION AND TRANSMISSION PIPELINES AND SYSTEMS

UCARCIDETM 125 Antimicrobial should be added to a gas production or transmission pipeline via direct injection. The application should be conducted to ensure maximum distribution of the UCARCIDETM 125 Antimicrobial through the entire internal surface of the pipeline. To facilitate application, it may be desirable to dilute the UCARCIDETM 125 Antimicrobial with an appropriate solvent immediately before use. Injections to the system should be weekly, or as needed to maintain control.

### GAS STORAGE WELLS AND SYSTEMS

Individual injection wells should be treated with a sufficient quantity of UCARCIDETM 125
Antimicrobial to produce a concentration of 1,000 to 10,000 ppm UCARCIDETM 125 Antimicrobial when diluted by the water present in fine formation, Injection should take place before gas is injected (during the summer). Injections should be repeated yearly, or as needed to maintain control.

Individual drips should be treated with a sufficient quantity of UCARCIDETM 125 Antimicrobial to produce a concentration of 400 to 4,000 ppm UCARCIDETM 125 Antimicrobial when diluted by the water present in the drip. Injections should be repeated yearly, or as needed to maintain control.

### HYDROTESTING

Water used to hydrotest pipelines or vessels should contain 200 to 8,000 ppm UCARCIDETM 125 Antimerobial (0.2 to 8.0 gallons UCARCIDETM 125 Antimerobial per 1,000 gallons water), depending on water quality and length of time the equipment will remain idle.

### PIPELINE PIGGING AND SCRAPING OPERATIONS

Add UCARCIDETM 125 Antimicrobial to a slug of water immediately following the scraper liceally this water volume can be kept to a minimum and contained between the scraper and a trailing pig. Sufficient UCARCIDETM 125 Antimicrobial should be added to produce a concentration of 0.2 to 2% (0.2 to 2.0 gallons UCARCIDETM 125 Antimicrobial per 100 gallons water), depending on the engine of the pipeline and the severity of biofouling.
