For short storage times (up to about 1 month), temperatures of up to 100°F (37.8°C) can be tolerated but the preferred maximum storage temperature is about 80°F (26.7°C). UCARCIDETM 114 Antimicrobial should be added to a water flood system at a point of uniform mixing.

Initial Treatment: When the system is noticeably contaminated, add 100 to 5,000 ppm UCARCIDETM 114 Antimicrobial to the system (0.3 to 15.2 gallons UCARCIDETM 114 Antimicrobial per 1,000 gallons flood water). Repeat until control is achieved.

Subsequent Dose: When microbial control is evident, add 60 to 15,150 ppm UCARCIDETM 114

to the system weekly, or as needed to maintain control.

DRILLING, COMPLETION, AND WORKOVER FLUIDS

Initial Treatment: Add 150 to 3,030 ppm UCARCIDETM 114 Antimicrobial (0.6 to 12.1 gallions UCARCIDETM 114 Antimicrobial per 100 barrels of fluid) to a freshly prepared fluid depending on the severity of contamination.

Maintenance Dosage: Maintein a concentration of 150 to 3,030 ppm UCARCIDETM 114

Antimicrobial by adding 0.6 to 12.1 gallons of UCARCIDETM 114 Antimicrobial per 100 barrels of additional fluid, or as needed, depending on the severity of contamination.

PACKER FLUIDS

UCARCIDETM 114 Antimicrobial should be added to a packer fluid at a point of uniform mixing such as a circulating holding tank. Add 150 to 1,820 ppm UCARCIDETM 114 Antimicrobial (0.6 to 12.1 gallons UCARCIDETM 114 Antimicrobial per 100 barrels of fluid) to a freshly prepared fluid depending on the severity of contamination. Seal the treated packer fluid in the wall between the casing and production tube.

GAS PRODUCTION AND TRANSMISSION PIPELINES AND SYSTEMS

UCARCIDETM 114 Antimicrobial should be added to a gas production or transmission pipeline via direct injection. The application should be conducted to ensure maximum distribution of the UCARCIDETM 114 Antimicrobial through the entire internal surface of the pipeline. To facilitate application, it may be desirable to dilute the UCARCIDETM 114. Antimicrobial with an appropriate solvent immediately before use. Injections to the system should be weekly, or as needed to maintain control.

GAS STORAGE WELLS AND SYSTEMS

Individual injection wells should be treated with a sufficient quantity of UCARCIDETM 114.

Antimicrobial to produce a concentration of 1,520 to 15,150 ppm UCARCIDETM 114. Antimicrobial when diluted by the water present in the formation. Injection should take place before gas is injected (during the summer). Injections should be repeated yearly, or as needed to maintain control.

Individual drips should be treated with a sufficient quantity of UCARCIDETM 114 Antimicrobial to produce a concentration of 610 to 8,060 ppm UCARCIDETM 114 Antimicrobial when diluted by the water present in the drip. Injections should be repeated yearly, or as needed to maintain control.

HYDROTESTING

Water used to hydrotest pipelines or vessels should contain 300 to 12,120 ppm UCARCIDETM 114 Antimicrobial (0.9 to 12.1 gallons UCARCIDETM 114 Antimicrobial per 1,000 gallons water), depending an water quality and length of time the equipment will remain idle.

PIPELINE PIGGING AND SCRAPING OPERATIONS
