UCARCIDE 130 LT Antimicrobial is incompatible with many commonly used materials of construction such as steel, galvanized iron, aluminum, tin, and zinc. UCARCIDE 130 LT Antimicrobial can be stored and handled in baked phenolic-lined steel, polyethylene, stainless steel, or reinforced epoxy-plastic equipment. This product freezes at about -45.4°F (-43°C). Therefore, unless the storage tank is inside or underground, heating and insulation may be required. If heating is needed, exposure to high temperatures should be avoided. For short storage times (up to about 1 month), temperatures of up to 100°F (37.8°C) can be tolerated but the preferred maximum storage temperature is about 80°F (26.7°C). A stainless steel centrifugal pump is suggested for transfer service. Spiral-wound stainless steel with TEFLON® Polymer is suitable for gaskets and packing.

Handle in a well-ventilated area. If vapors are irritating to the nose or eyes, special ventilation or respiratory protection (MSHA/NIOSH approved air purifying respirator equipped with an organic vapor cartridge) may be required.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

WATER FLOODS

UCARCIDE 130 LT Antimicrobial should be added to a water flood system at a point of uniform mixing.

initial Treatment: When the system is noticeably contaminated, add 167 to 8,333 ppm UCARCIDE 130 LT Antimicrobial to the system (0.17 to 8.4 gallons UCARCIDE 130 LT Antimicrobial per 1,000 gallons flood water). Repeat until control is achieved.

Subsequent Dose: When microbial control is evident, add 33 to 8,333 ppm UCARCIDE 130 LT Antimicrobial 1.033 to 8.4 gallons UCARCIDE 130 LT Antimicrobial per 1,000 gallons flood water) to the system weekly, or as needed to maintain control.

DRILLING, COMPLETION, AND WORKOVER FLUIDS

UCARCIDE 130 LT Antimicrobial should be added to a drilling fluid system at a point of uniform mixing such as the circulating mud tank.

Initial Treatment: Add 90 to 1,665 ppm UCARCIDE 130 LT Antimicrobial (0.38 to 7.1 gallons UCARCIDE 130 LT Antimicrobial per 100 barrels of fluid) to a freshly prepared fluid depending on the severity of contamination.

Maintenance Dosage: Maintain a concentration of 90 to 1,665 ppm UCARCIDE 130 LT Antimicrobial by adding 0.38 to 7.1 gallons of UCARCIDE 130 LT Antimicrobial per 100 barrels of additional fluid, or as needed, depending on the severity of contamination.

PACKER FLUIDS

UCARCIDE 130 LT Antimicrobial should be added to a packer fluid at a point of uniform mixing such as a circulating holding tank. Add 90 to 1,005 ppm UCARCIDE 130 LT Antimicrobial (0.38 to 4.3 gallons UCARCIDE 130 LT Antimicrobial per 100 barrels of fluid) to a freshly prepared fluid depending on the severity of contamination. Seal the treated packer fluid in the wall between the casing and production tube.

GAS OR OIL PRODUCTION AND TRANSMISSION PIPELINE SYSTEMS

UCARCIDE 130 LT Antimicrobial should be added to a gas or oil production or transmission pipeline via direct injection. The application should be conducted to ensure maximum distribution of the UCARCIDE 130 LT Antimicrobial through the entire internal surface of the pipeline. Pipelines should be treated with a sufficient quantity to produce a concentration of 840 to 8340 ppm of UCARCIDE 130 LT Antimicrobial when diluted by the water phase present within the pipeline system. To facilitate application in gas pipeline systems, it may be desirable to dilute the UCARCIDE 130 LT Antimicrobial with an appropriate solvent immediately before use. Injections to the gas or oil pipeline system should be weekly, or as needed to maintain control.

HYDROTESTING

Water used to hydrotest pipelines or vessels should contain 165 to 6,660 ppm UCARCIDE 130 LT Antimicrobial (0.17 to 6.7 gallons UCARCIDE 130 LT Antimicrobial per 1,000 gallons water), depending on water quality and length of time the equipment will remain

PIPELINE PIGGING AND SCRAPING OPERATIONS

Add UCARCIDE 130 LT Antimicrobial to a slug of water immediately following the sc (ideally this water volume can be kept to a minimum and contained between the scrape; and a trailing pig). Sufficient UCARCIDE 130 LT Antimicrobial should be added to produce a concentration of 0.15 to 1.7% (0.15 to 1.7 gallons UCARCIDE 130 LT Antimicrobial per 100 gallons water), depending on the length of the pipeline and the severity of biofouling.

STORAGE AND DISPOSAL

PESTICIDE DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited. Pesticide wastes are toxic.
