The concentration required to give protection depends on several factors: These include the susceptibility of the system to microbiological degradation, the extent to which microorganisms can gain access, the species involved, pH, temperature and the length of time for which protection is required. For protection against bacterial attack a use concentration between 0.02- 0.35% CANGUARD BIT 20 AS Preservative is normally sufficient. Dose levels greater than 0.25% may be necessary on occasion for control of mold growth, particularly on paste products with high solids content. In dilute fluid systems control of spoilage is normally controlled with dosages not exceeding 0.09%.
