CAUTION**

Harmful if swallowed, inhaled, or absorbed through skin. If swallowed, call physician immediately. NOTE TO PHYSICIAN-Solvent presents aspiration hazard. Gastric lavage is indicated if material was taken internally. If symptoms of cholinesterase inhibition are present, atropine is antidotal. 2-PAM is also antidotal and may be used in conjunction with atropine. Do not smoke while using. Avoid excessive wetting of plastic, vinyl or asphalt tile floor surfaces. Avoid breathing spray mist and contact with skin, eyes or clothing. Provide adequate ventilation of area being treated. Do not apply to humans or pets or contaminate feed, foodstuffs, dishes and utensils. Wash thoroughly after use and before smoking or eating. Do not allow children in treated areas until surfaces are dry.

STATEMENT OF PRACTICAL TREATMENT

- If Swallowed - Call a physician or Poison Control Center immediately. DO NOT INDUCE VOMITING. Vomiting may cause aspiration pneumonia.

Hornets, Wasps, Bees and Cicada Killers: Spray a stream directly on nests, especially around openings. The stream can be directed up to 15 feet. Apply to nesting areas at dusk, when possible, since most insects are then in their nests and less active. Spray around window and door frames, under shutters, under eaves and siding, around rafters and other areas where wasps or hornets may nest. Repeat applications when necessary.
