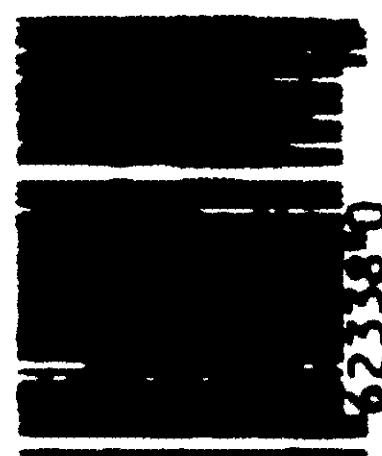

DIRECTIONS

FOR RATS PLACE 2 OR 3 UNOPENED POUCHES next to burrows, in runways and in locations frequented by rodents.

FOR MICE, USE AN UNOPENED POUCH near burrows and runways. Protect from children, pets or livestock with boxes or cages where necessary. Use at 8 to 12 foot intervals.

FOR BEST RESULTS: Check bait daily. **FOR RATS,** furnish continuous supply of bait for not less than 12 days. **FOR MICE,** bait continuously for not less than 15 days. Continue bait until all signs of feeding have stopped.

IMPORTANT: If bait becomes damp, moldy or stale, replace with fresh pouch immediately.

CAUTION: Protect children, pets, wildlife and domestic animals from the bait. If swallowed by humans, domestic animals or pets, call a physician or veterinarian immediately. The product may reduce the clotting ability of blood and cause internal bleeding. Antidote—Vitamin K.

Baits should be placed in areas not accessible to children, pets, wildlife and domestic animals or in tamper-proof bait boxes. Do not allow treated bait to be exposed on bare ground. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label.
