FOR TERMITE CONTROL AND FOR PROTECTION AGAINST TERMITE INFESTATION

Termites must maintain daily contact with the soil for moisture. Black Flag Termite Killer when properly applied acts as a chemical barrier to kill existing termites and to protect against infestation. One application will last over five years.

"SUBTERRANEAN TERMITES-Directions for Non-Professional Use.

Use 1 pint of Black Flag Termite Killer and Control in 6 gallons of water to make a 10%, water emulsion mixture. Use this mixture for all termite applications listed.

BUILDINGS HAVING BASEMENTS or CRAWL SPACES:

Dig a trench along the outside of the foundation walls. In brick or hollow block or concrete foundations, dig a trench to, but not below, the footing. Then as the trench is refilled treat the soil at the rate of 4 gallons per 10 linear feet for each foot of depth. A trench 3 feet deep would require 12 gallons per 10 linear feet.

The objective is to establish a treated soil barrier which will prevent termite entry. Other critical areas may also require treatment. It is suggested that you consult the State Extension Service for advice "

FOR CRAWL SPACES UNDER BUILDINGS and PORCHES:

Apply one gallon of water mixture to 10 sq. ft of soil area. Also, thoroughly wet foundation walls, piers and surrounding soil.

AROUND PORCHES and in BASEMENTS:

Apply water mixture at the rate of 2 gallons per 5 linear feet between the house and porch. It may be necessary to drill holes (1 foot apart) in porch floor for proper application.

Treat basement floors especially around wooden stairs or pillars that may be embedded in the floor by drilling holes in the floor and applying the water mixture.

SPOT TREATMENTS:

For light termite infestation, treatment of localized areas around porches or along foundations may be all that is necessary. Treat according to trench or porch directions at the rate of 2 gallons of water mixture per 5 linear feet.

CAUTION: Harmful if swallowed. Contact with skin can cause toxic symptoms. Avoid breathing spray mists. In case of contact with skin, wash with soap and water. Avoid contamination of feed and foodstuffs. Keep out of reach of children
