BACK PANEL

Sani-Flush has an exclusive formula with "blue bubbling action" for extra tough [serious] cleaning problems. It is specially formulated to remove tough hard water stains. Sani-Flush rmoves tough rust stains and stubborn bowl deposits. It is also a strong disinfectant to kill most household germs fast [even staph and odor causing germs]. Leaves bowl sparkling clean, hygienic and sanitary. [Regular use of Sani-Flush keeps white or colored bowls stain free, sanitary, sparkling and bright.] Safe for septic tanks and plumbing. Use on toilet bowls only. Do not use on enameled or metal fixtures such as bathtubs and sinks. [Contains no phosphates.]

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its lab ng.

TO OPEN CHILD-RESISTANT CAP: Push cap down while turning counter-clockwise. TO CLOSE: Screw cap on tightly clockwise. When locked, cap will click when turned counter-clockwise without pushing down.

TO CLEAN AND DISINFECT: Flush toilet while brushing interior of bowl, wetting surfaces thoroughly, including under the rim. When water has stopped running, shake 1/2 cup or more around the bowl sides and in the water. Let stand at least 10-15 minutes. Brush all surfaces before flushing. Repeat twice weekly for thorough cleanliness.

For badly stained bowls [To remove stubborn, persistent bowl stains]: Lower the water level in the bowl as much as possible. Reapply 1/2 cup or more of Sani-Flush on to the stained area. Let stand for several hours, or preferably, overnight. Flush toilet, brush thoroughly, then flush again. [In between cleanings, use Sani-Flush 4-Month Automatic Bow] Cleaner for continuous cleaning and deodorizing action.]

PHYSICAL AND CHEMICAL HAZARDS
