## PROFESSIONAL POWER LIQUID ANT and ROACH KILLER

Contains Baygon for fast, long killing action. Effective against chlorinated hydrocarbon and phosphate resistant roaches. Contains DDVP for vaporizing and penetrating action through cracks to get back of walls.

**CAUTION: DO NOT USE AS A SPACE SPRAY. DO NOT USE, POUR, SPILL, OR STORE NEAR HEAT OR OPEN FLAME.**

Harmful if swallowed, inhaled or absorbed through skin. If swallowed, call physician immediately. Note to Physician: Atropine is antidotal. Avoid breathing spray mist and contact with skin, eyes or clothing. Provide adequate ventilation of area being treated. Do not apply to humans and pets or contaminate feed, foodstuffs, dishes and utensils. Wash thoroughly with soap and water after use. Avoid excessive wetting of plastics, painted surface, vinyl or asphalt tile floor surfaces. Do not allow children on treated areas until surfaces are dry.

Do not reuse empty container. Destroy it by perforating or crushing. Bury or discard in a safe place away from water supplies.

### DIRECTIONS FOR HOUSEHOLD USE

Use only as a surface spray. Spray from a distance of 1 foot until surfaces are wet. Repeat applications as necessary.

**ROACHES, WATERBUGS, RESISTANT ROACHES, CRICKETS, CENTIPEDES, SPIDERS AND EARWIGS:** Spray in hiding places, cracks, along baseboards, under sinks and places where insects hide. Spray bugs directly when they are driven out by the spray. Repeat as necessary.

**ANTS:** Spray ants, ant trails and ant hills. Spray around doors and windows where ants enter. Repeat as necessary.

**ACTIVE INGREDIENTS:** 2-(1-Methylethoxy) phenol methylcarbamate 0.95%; 2,2-dichlorovinyl dimethyl phosphate (DDVP) 0.186% and 0.014% related compounds; Petroleum distillates 82.12%
