DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

DIRECTIONS: SHAKE WELL BEFORE USING

Remove protective cap. Push button to spray. Spray only in upright position.

CRAWLING BUGS

TO KILL ANTS, ROACHES, WATERBUGS, SPIDERS. Spray directly on insects where damage and into cracks and crevices. For ANTS, also spray on trails and entry points.

BITING BUGS

TO KILL FLEAS & TICKS. Spray directly on insects where possible. Spray high corners of bedding, upholstered furniture and wherever bugs are seen.

FLYING BUGS

TO KILL HOUSEFLIES, MOSQUITOES, GNATS. Spray directly on insects where possible. To clear insects from room, close windows and doors, spray upward with sweeping motion until room is thoroughly misted. Vacuum room for at least 15 minutes and aerate before re-entering.

To kill outdoor pests, hold container 4 to 6 feet away from parts of trees and spray in a sweeping motion when or as you see them.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed, inhaled or absorbed through the skin. Avoid contact with skin, eyes and clothing. In case of contact, immediately flush eyes or skin with plenty of water. Cover or remove exposed foods. Avoid contamination of cooking utensils and food processing surfaces. Remove pets, fish bowls and bird cages from rooms being sprayed. Do not spray on humans or pets.

ENVIRONMENTAL HAZARDS

This pesticide is highly toxic to fish. Do not apply directly to water or wetlands (swamps, bays, marshes, and pot holes). Drift from treated areas may be hazardous to organisms in adjacent aquatic sites. Spray ornamental plants from 4 to 6 feet away.

PHYSICAL HAZARDS

Contents under pressure. Do not store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting. Avoid freezing.

Do not reuse empty container. Wrap container and put in trash collection.
