PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed or absorbed through skin. Avoid breathing vapors. Avoid contact with skin. In case of contact, immediately flush skin with plenty of water.

Do not use in commercial food processing, storage, preparation or serving areas. In the home, all food processing surfaces and utensils should be covered during treatment, or thoroughly washed before use. Cover exposed food.

Remove pets, birds and cover fish aquariums before spraying.

PHYSICAL HAZARDS

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or mutilate container. Exposure to temperatures above 130 F may cause bursting.

DIRECTIONS FOR USE

GENERAL CLASSIFICATION

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

STORAGE AND DISPOSAL

Storage: Store in a cool area away from heat or open flame.

Disposal: Do not reuse empty container. Wrap container and put in trash collection.

SHAKE WELL BEFORE USING. Hold can upside down about 2 feet away from area to be treated. To spray, press button to side. Moving quickly, spray evenly using sweeping motion to cover area to be treated.

TO KILL FLEAS AND BROWN DOG TICKS:

Directly spray as many pests as possible. Spray both interior and exterior of upholstered furniture. Both top and bottom of rugs and carpets should be sprayed thoroughly. Remove and destroy old pet bedding. Spray sleeping quarters of pets around baseboards, window and door frames, wall cracks and focal areas of floors and wherever these insects are seen or suspected. Repeat as necessary. Do not spray animals. Put fresh bedding in pets quarters after spray has dried. Also treat dogs and cats with a registered flea and tick control product before allowing them to enter treated areas.

TO KILL CARPET BEETLES:

Directly spray as many insects as possible. Spray both interior and exterior of upholstered furniture. Both top and bottom of rugs and carpets should be sprayed thoroughly. Also treat shelves, closets, areas under furniture and wherever these insects are seen or suspected. Repeat as necessary.
