INDOOR FOGGER SPRAY

The contents of this container will treat an unobstructed area of approximately 5,000 cubic feet. This is based on utilizing at least one (1) ounce of contents per 1,000 cubic feet. If area is larger, use additional containers. The fine aerosol particles kill exposed and accessible stages of small flying moths, spiders, wasps, silverfish, roaches, flies, gnats, ants, mosquitoes, fleas, waterbugs, bees, crickets, adult stages of carpet beetles.

DIRECTIONS FOR USE

Remove pets from areas to be treated and close doors and windows. In order to do a completely effective job, leave cupboards, closets and trunks open. Turn off fans, air conditioners and extinguish all flames. Cover all food and utensils from direct contact with the spray.

Place can on a raised area such as a table; spread paper under the can to protect the area directly beneath the sprayhead and can. Remove cap, tilting can away from your face. Latch the hook firmly over rim of can by placing the thumb over the arrow and pressing forward (see illustration). Leave the room; the spray will continue until the complete contents have been released. For maximum effectiveness keep treated area closed to two (2) hours or more, then open windows and doors and allow space to air for thirty (30) minutes.

WARNING: Contents under pressure. Do not puncture. Do not use or store near heat or open flame. Exposure to temperatures above 130°F may cause bursting. Never throw container into fire or incinerator. When used in an enclosed area, vacate premises during treatment and ventilate the area once treatment is completed. Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using the product in these area, apply only when the facility is not in operation. Keep out of the reach of children.
