
This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) provided that you:

- 1. Submit and/or cite all data required for registration/ reregistration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.
 - Make the following label changes:
 - a. Revise the EPA Registration Number to read, "EPA Reg. No. 475-339".
 - b. Claims such as new and new improved may be used on the product labeling for a period of 6 months following the approved labeling. Thereafter these claims must be deleted.
 - c. Non-specific terminology or comparative words without valid comparison and words or phrases which implies a pesticide product possess unique characteristics because of its composition are unacceptable. Therefore delete the following statements: "Long lasting formula", "works longer", Kills many species of insects", "Kills long", "Keeps on killing even after surface is dry", Kills on contact and keeps workings with residual action even when it dries", "Killing roaches doesn't get any faster", "Low VOC formula", New reduced VOC formula".

- d. Delete the statement "Contains no CFC propellents" from the labeling since words or phrases implying to the safety of a pesticide in any form are We will accept the second CFC unacceptable. statement appearing on the label in accordance to PR Notice 92-2.
- Since we are unable to verify the Clean Air Act е. Standards for California, delete the "Complies with California Clean Air Act Standards".
- f. Under Hazards to Humans and Domestic Animals and Statements of Practical Treatment, you may delete the statements "Harmful if swallowed" and the IF SWALLOWED statements since the acute oral toxicity is Category IV.
- Delete the pest "deer ticks" from the labeling h. since you have not cited/submitted the required efficacy data to support claims on public health pests.
- Unless you can qualify the residual effectiveness i. of the formulation with a time frame (based upon data) i.e. last for 3 weeks, delete claims Oriental and American roaches. You need to cite/submit efficacy data to support these claims. retain German cockroaches with claims for residual control limited up to 12 weeks.
- We prefer the user limitation, "For Household Use j. only" to appear on the front panel.
- Delete the "+" in the product name or identify what k. the "+" refers to.
- Change "window sills" to "window frames" on the 1. back panel.
- Submit two copies of the revised final printed label for the record.
- 4. With regards to the product chemistry, please provide the oxidizing or reducing action data (Guideline 63-14) for the subject product.

Bed bugs

Spray directly on insects (pests) whenever possible. Thoroughly spray cracks, crevices, basehoards, underneath chairs, tables, beds and sofas, around points of entry such as window sills and other places where these insects (pests) are observed. Holding can two feet from surfaces to be treated, thoroughly spray cracks, crevices, shelving and baseboards. Allow to dry before replacing contents. Do not allow food to directly contact treated surfaces. Repeat as needed.
