It reaches fleas hidden in carpets, rugs, drapes, upholstery, pet bedding, floor cracks. Protects your home from reinfestation and fleas buildup, your pets and family from bites. One treatment with this spray gives continuous flea protection for 120 days. Leaves no objectional odor or sticky mess and, used as directed, does not stain furnishings.

FLEAS & TICKS: SHAKE WELL. Hold can 2 or 3 feet from surfaces to be treated. Be sure to apply uniformly using a sweeping motion to carpets, rugs, drapes and all surfaces of upholstered furniture. Be sure to treat pet bedding as this is a primary hiding

place for fleas. No need to remove pet bedding after treatment. DO NOT TREAT PETS. Use a registered flea control product on your pets in conjunction with this treatment. Retreat as necessary.
