DIRECTIONS FOR USE

Apply when air is calm using power dusting equipment or aircraft. Apply 25 pounds per acre at the first sign of infestation and repeat at 7 to 10 day intervals as needed to achieve control but observe use limits given for specific crops.

RECOMMENDATIONS

COLE CROPS (Broccoli, Brussels Sprouts, Cabbage, Cauliflower, Kohlrabi)—Cabbage looper, imported cabbage worm. Do not apply within 3 days of harvest.

LETTUCE—Alfalfa looper (Pacific Coast states) cabbage looper, imported cabbage worm, leafminer. Do not apply within 4 days of harvest.

SPINACH—Cabbage looper, leafhoppers. Do not apply within 7 days of harvest.
