IN-FURROW APPLICATION: For protection against root rot (Rhizoctonia) and stem rot (Pythium), apply 10-15 pounds Captan PCNB 10-10 D u s t per acre based on a 30" row spacing. Increase rates per acre proportionately as the row spacing decreases. Application should be made to the planting furrow and covering soil at time of planting.

RECOMMENDATIONS

CAPTAN-PCNB 10-10 D U S T is a special formulation for use at time of planting to protect beans and cotton seed and seedlings against soil borne diseases.

DIRECTIONS FOR USE COTTON

For protection against damp-off, seed rot, Rhizoctonia (Soreskin) and Phythium.

IN-FURROW APPLICATION: Apply 15 pounds of Captan-PCNB 10-10 D u s t per acre based on a 30" row spacing. Increase the rate per acre proportionately as the row spacing decreases. For example, on a 24" row spacing, use 1834 pounds per acre; on an 18" row spacing, use 25 pounds per acre, and on a 14" row spacing, use 32 pounds per acre. Application should be made to the planting furrow and covering soil at the time of planting.

PLANTER BOX APPLICATION: Use 5 pounds Captan-PCNB 10-10 D u s t per acre. The seed and the proper amount of this material may be premixed in a container just prior to dumping in the planter box, or the chemical may be added to the seed in the planter box and blended by stirring or mixing thoroughly. Planter box application is not intended as a substitute for regular seed treatment. Is is a supplement to proper chemical treatment of good seed.

HILL-DROP SEEDING — PLANTER BOX APPLICATION: Use 3 pounds Captan-PCNB 10-10D u s t for hill-drop seeding rate of 15-25 pounds per acre. Balance of directions for planter be application given above apply to hill-drop seeding method.
