
DIRECTIONS FOR USE

This formulation is for use in the dry powder form for dust treatment of seeds for profaction against seed rot, damping-off, seed com beetles, seed cork maggots and wireworms. Mix seed with recommended amount of this material, in any commercial seed treater or barren treater, until thoroughly coated. DO NOT MIX WITH HANDS. May be used on seed previously treated with a fungicide. Avoid lengthy storage of treated seed to prevent loss of LINDANE. If soil temperature is extremely high due to low moisture, hot weather or mid summer planting time, reduce the following dosage rates by one-half:
