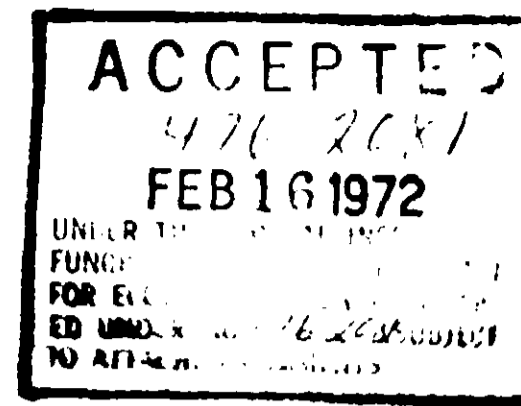

PLANTER BOX OR DRILL BOX APPLICATION: USE ON SEED BY MIXING WITH THE SEED IN THE BOX AT THE RATE SHOWN BELOW. DO NOT MIX WITH HANDS.

PLANTER BOX OR DRILL BOX RATES:

WHEAT, OATS, BARLEY, RYE	2 TO 4 OZ./BU.
CORN SEED (FIELD)	2 TO 4 OZ./BU.
SOYBEANS, BEANS, PEAS	2 TO 4 OZ./BU.
PEANUTS (SHELLED)	4 TO 6 OZ./BU.

SLURRY APPLICATION: MIX 1 POUND OF THIS MATERIAL WITH 1 GALLON OF WATER IN THE SLURRY MACHINE. SETTINGS OF THE MACHINERY CAN BE ADJUSTED TO APPLY THE RATES LISTED ABOVE TO THE SEED. FURTHER SPECIFIC INFORMATION ON THIS SUBJECT MAY BE OBTAINED FROM STATE AGRICULTURAL EXPERIMENT STATIONS OR THE STATE AGRICULTURAL EXTENSION SERVICE.
