

GENERAL USE PRECAUTIONS

Read all label instructions before using. Do not overdose. ORDRAM should be used only for recommended purposes and at recommended rates. ORDRAM may cause crop injury under extreme soil or climatic conditions or if directions are not followed.

Except as specified on this label, do not apply other herbicides in conjunction with ORDRAM as injury may occur.

ORDRAM may be combined with fluid (solution, slurry, or suspension) fertilizers. However, physical compatibility with these fluid fertilizers must be determined before combining in the spray tank. See special literature giving directions for these combinations. Even though found to be compatible, constant agitation is necessary to keep the ORDRAM uniformly mixed with the fluid fertilizer.

DO NOT STORE NEAR SEEDS OR FERTILIZER.

KEEP CONTAINER CLOSED WHEN NOT IN USE.

DO NOT CONTAMINATE WATER USED FOR DOMESTIC PURPOSES.

GENERAL APPLICATION DIRECTIONS

All equipment used in the application of ORDRAM should be carefully calibrated before use and checked frequently during application to be sure the application is uniform. Avoid overlaps that will increase ORDRAM dosages above recommended limits because crop injury may occur. Apply ORDRAM 8-E in 10 to 50 gallons of water by ground equipment and 5 to 10 gallons of water by airplane except as specified below.

To avoid uneven distribution of ORDRAM in flooded fields the water flow through the field should be at a minimum at the time of application and for at least two hours after application.

Do not apply more than 6 pounds actual ORDRAM (6 pints ORDRAM 8-E) per acre per season where more than one method of application is used. Allow 30 days between applications.

DIRECTIONS FOR USE AND RECOMMENDATIONS

1. **PRE-PLANT, PRE-FLOOD:** For use on water-seeded rice ONLY.

For control of Watergrass (Barnyardgrass) *Echinochloa* spp. ONLY.

SOIL PREPARATION: Prepare the soil for seeding according to good agricultural practices. All weed growth must be thoroughly worked into the soil before treatment.

FOR GROUND APPLICATION ONLY: Use standard low-pressure (20-50 psi) boom-spray equipment. DO NOT USE SINGLE NOZZLE BOOM-JET TYPE SPRAYERS.

APPLICATION AND INCORPORATION: Apply to dry soil in good tilth. ORDRAM must be incorporated immediately (within minutes) to prevent loss of the herbicide. Whenever possible, application and incorporation should be done in the same operation. Incorporation should be done by at least one discing or spiketooth harrowing. Flood the field for seeding and hold the flood for 4 to 6 days following seeding.

RECOMMENDED RATE: Apply 3 pints ORDRAM 8-E per acre.

2. **POST-EMERGENCE, PRE-FLOOD:** For use on dry-seeded and water-seeded rice.

For control of Dayflower (*Commelina communis*) in the two leaf stage or less and small Sprangletop (*Leptochloa* spp.) emerged less than one inch, apply ORDRAM 8-E as a tank mix combination with a registered propanil brand in 10-15 gallons of water per acre by airplane or in 20-50 gallons of water per acre by ground equipment. Flood the rice within 5 days after treatment. Follow all directions and use precautions on the propanil label. Avoid drift or accidental application to all crops, shrubs or ornamentals not in the rice field being treated.

RECOMMENDED RATE: 2 to 3 pints ORDRAM 8-E (3 pints for Sprangletop) plus 3 pounds actual propanil per acre.

3 POST-EMERGENCE AT FLOODING: For use on dry-seeded rice ONLY.

For control of Watergrass (Barnyardgrass) and Dayflower under 5 inches tall.

When establishing the permanent flood, meter the recommended rate of ORDRAM 8-E per acre into the irrigation water at the header ditch or canal where water enters the treated field. Meter the ORDRAM during the entire irrigation period using a constant head metering device.

RECOMMENDED RATE: 3 pints ORDRAM 8-E per acre.

The rice must be established at the time of application. Dayflower must be completely submerged and Barnyardgrass 2/3 submerged by the flooding operation. Flood should be maintained at the prescribed depth until Barnyardgrass and/or Dayflower is controlled.

4. POST-EMERGENCE, POST-FLOOD: For use on dry-seeded and water seeded rice.

For control of Watergrass (Barnyardgrass) ONLY.

APPLICATION: Apply the recommended rate directly to the flooded field. Apply by airplane ONLY. Apply only when wind velocity is low, 0 to 5 mph.

RECOMMENDED RATE: 3 pints ORDRAM 8-E per acre.

The Watergrass must be a minimum of 2 inches high but not higher than 5 inches, and it must be at least 2/3 submerged at time of application. This water level (not less than 2 inches) must be maintained until the Watergrass dies. Application should be made before rice is 2 inches above surface of water.
