

If Swallowed: Immediately give several glasses of water and induce vomiting by gagging the victim with a finger placed on the back of the victim's tonque. Give fluids until vomitus is clear. If victim is unconscious or convulsing, do not induce vomiting or give anything by mouth.

For Eye Contact: Hold eyelids apart and flush eyes with large amounts of running water for 15 minutes. Seek medical attention if irritation occurs.

For Skin Contact: Flush all affected areas with plenty of water for several minutes. Remove and clean contaminated clothing and shoes. Seek medical attention if skin irritation occurs.

If Inhaled: Remove to fresh air. Get medical attention if respiratory irritation occurs or if breathing becomes difficult.
