Physical and Chemical Hazards

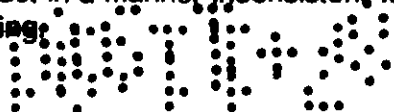
Contents under pressure. Do not use near heat or open flame. Do not puncture or incinerate. Exposure to temperatures above 130°F may cause bursting.

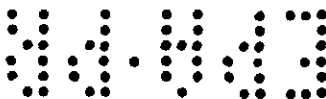
