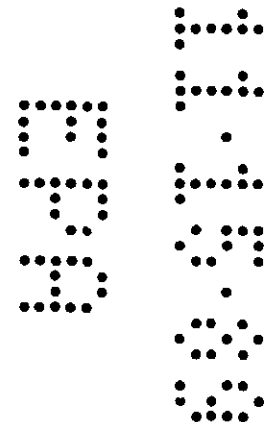

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION

KEEP OUT OF REACH OF CHILDREN.

DIRECT SPRAY AWAY FROM PEOPLE OR ANIMALS.

Harmful if swallowed or absorbed through skin. Avoid breathing vapor and spray mist. Avoid contact with skin and eyes. Do not apply directly to food in commercial food handling facility. Cover or remove any food and food processing equipment during application. Do not apply while food processing is under way. After space spraying, leave packing plant, bakery and other food processing plants, wash all equipment, benches, shelving and so on where exposed food will be handled. When potable water is used in the home or food processing plant, surfaces and utensils should be covered during treatment or thoroughly washed before use. Remove pets, birds and cover fish aquariums before spraying.

STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED: Call a physician or Poison Control Center immediately. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Repeat until vomit fluid is clear. Never induce vomiting or give anything by mouth to an unconscious person.

IF ON SKIN: Wash contaminated clothing and wash affected areas with plenty of soap and water.

IF IN EYES: Flush eyes with plenty of water. Call a physician if irritation persists.

IF INHALED: Remove victim to fresh air. Apply artificial respiration if indicated.

ENVIRONMENTAL HAZARDS

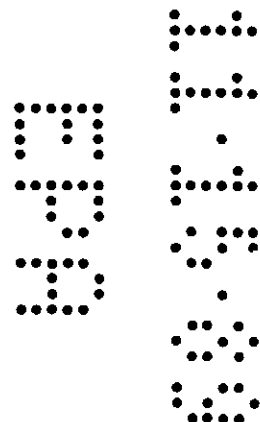

SHAKE WELL. Hold can upright.

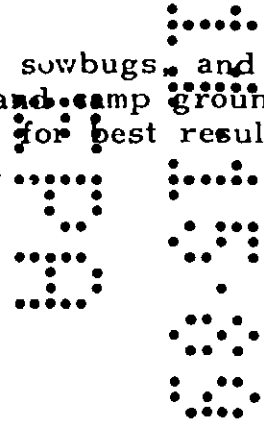
For best results, spray when air is calm or breeze is slight.

On calm days, spray from center.

On windy days, spray with wind.

FLYING INSECTS: Flies, Mosquitoes, Gnats. Spray with any breeze
and allow fog to drift over area. Spray bushes and grasses from 4
to 6 feet away. Spray garbage cans and other breeding areas. Spray
wasp nests at night when they are less active.

CRAWLING INSECTS: Spray directly on ants, centipedes, sowbugs, and
spiders. Treat areas around garbage cans, picnic sites and camp grounds
infested by these pests. Also thoroughly spray ant hills for best results.
Spray legs of chairs and tables to repel crawling insects.
