**WARNING:**

**Hazards to Humans and Domestic Animals**

**Statement of Practical Treatment**

**If Swallowed:** Call a physician or Poison Control Center immediately. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Repeat until vomit fluid is clear. Never induce vomiting or give anything by mouth to an unconscious person. **If on Skin:** Wash contaminated clothing and wash affected areas with plenty of soap and water. **If In Eyes:** Flush eyes with plenty of water. Call a physician if irritation persists. **If Inhaled:** Remove victim to fresh air. Apply artificial respiration if indicated. **NOTE TO PHYSICIAN:** This product may cause cholinesterase inhibition. Atropine is antidotal. 2-PAM may be effective as an adjunct to atropine.

**Environmental Hazards**

### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**Pests Indoors:** Prior to application de-energize electrical equipment. After application, allow time for oil to evaporate before starting motors or placing switches in the "ON" position. Do not use in poultry houses or other animal buildings housing meat or dairy animals. Do not allow spray to contact food, feedstuffs and water supplies. If dishes and food handling utensils become contaminated from application of this product, wash with soap and water before reuse. Do not spray air in rooms or use on plants. Remove pets and cover fish bowls (tanks) before spraying. Do not allow children or pets to contact treated surfaces until spray has dried. Remove sprayer from container after use.
