SHAKE WELL before each use. Hold can upright. Remove protective cap. Aim spray opening away from people. Push button to spray. Apply in short bursts.

KILLS THESE COMMON HOUSEHOLD PESTS
HOUSEFLIES, MOSQUITOES, SMALL FLYING MOTHS, GNATS: Close all doors and windows and direct spray upward into center of room with a slow sweeping motion. Spray 5-10 seconds for average room. Keep room closed for 15 minutes after spraying. Ventilate room thoroughly before re-entry. Sweep up and destroy fallen insects.

COCKROACHES, ANTS, CRICKETS, SOWBUGS, CENTIPEDES, FIREBRATS, SPIDERS: Contact as many insects as possible with the spray in addition to thorough spraying of all parts of the room suspected of harboring these pests. Special attention should be paid to cracks, hidden surfaces under sinks, behind stoves and refrigerators, food storage areas and wherever these pests are suspected of hiding. To kill ants, treat doors, around window frames, ant trails and other areas of entry. Repeat as necessary.

CARPET BEETLES: Directly spray as many insects as possible. Spray both interior and exterior of upholstered furniture. Both top and bottom of rugs and carpets should be sprayed thoroughly. Also treat shelves, closets, areas under furniture and wherever these insects are seen or suspected. Repeat as necessary.

CONFUSED FLOUR BEETLES, SAW-TOOTHED GRAIN BEETLES, RICE WEEVILS: Exposed Forms: Find and destroy infested packaged goods. Remove all other items from pantry. Spray the shelves to kill any of the named insects present. Place clean paper on shelves and return packages after shelves have dried. Repeat as necessary.

FLEAS, BROWN DOG TICKS: Remove and destroy old pet bedding. Spray sleeping quarters of pets around baseboards, window and door frames, wall cracks and local areas of floors. Repeat as necessary. Do not spray animals. Put fresh bedding in pets' quarters after spray has dried. Also treat dogs and cats with a registered flea and tick control product before allowing them to enter treated area.
