Subject: Application for Label Amendment, Real-Kill Household Flying Insect Killer, EPA Reg. No. 478-93

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

Modify the Precautionary Statements to read as follows:

CAUTION: Harmful if swallowed, inhaled, or absorbed through skin. Wash thoroughly with soap and water after handling. Avoid breathing vapor and spray mist. Avoid contact with skin, eyes, or clothing. Remove contaminated clothing and wash before re-use.

Modify the following Statements of Practical Treatment to read as follows:

If Swallowed: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. If person is unconscious, do not give anything by mouth and do not induce vomiting. If on Skin: Wash with plenty of soap and water. Get medical attention if irritation persists. If Inhaled: Remove victim to fresh air. If not breathing,

give artificial respiration preferably mouth to mouth. Get medical attention.

SHAKE WELL before each use. Hold can upright. Remove protective cap. Aim spray opening away from people. Push button to spray. Apply in short bursts.

KILLS THESE COMMON HOUSEHOLD PESTS HOUSEFLIES, MOSQUITOES (Optional: including Aedes aegypti mosquitoes which transmit dengue), SMALL FLYING MOTHS, GNATS: Close all doors and windows and direct spray upward into center of room with a slow sweeping motion. Spray 5-10 seconds for average room. Keep room closed for 15 minutes after spraying. Ventilate room thoroughly before re-entry. Sweep up and destroy fallen insects.

COCKROACHES, ANTS, CRICKETS, SOWBUGS, CENTIPEDES, FIREBRATS, SPIDERS: Contact as many insects as possible with the spray in addition to thorough spraying of all parts of the room suspected of harboring these pests.
