**Statement of Practical Treatment**

**If Swallowed:** Call a physician or Poison Control Center immediately. Do not induce vomiting. **If on Skin:** Wash contaminated clothing and wash affected areas with plenty of soap and water. **If In Eyes:** Flush eyes with plenty of water. Call a physician if irritation persists. **If Inhaled:** Remove victim to fresh air. Apply artificial respiration if indicated. **NOTE TO PHYSICIAN:** Contains petroleum distillate. If gastric lavage is deemed necessary, undertake only after proper placement of a cuffed endotracheal tube. Active ingredients contain a cholinesterase inhibitor. Treat symptomatically. Atropine is an antidote. 2 PAM is also antidotal and may be administered in conjunction with atropine.

**Roaches, Waterbugs, Crickets, Silverfish, Spiders, Scorpions.** Spray baseboards, cracks and crevices, around door and window frames, and other hiding places such as closets, in back of and under appliances, sinks, and cupboards in the kitchen and bathroom.
